Acquisition of AGC Group's Polycarbonate Business

(HQ: Chiyoda-ku, Tokyo, President & CEO: Yoshinori Hirai, hereinafter referred to as "AGC") and its subsidiary AGC Polycarbonate Co., Ltd. By taking over the achievements and technologies that AGC has built up to date and integrating the strengths of each company, we aim to improve our services to customers, develop our business and create new value.
